## I. TUITION AND FEES

Application Fee and Testing Fee- \$100 for each student

**Registration Fee -** The registration fee of \$200 is due when a child is accepted. *Application, testing and registration fees are non-refundable.* 

### Tuition

Cedar Grove Christian Academy Inc. has 2 payment plan options. Tuition can be paid monthly or yearly.

A family discount provides an allowance in the tuition structure for families with two or more children in grades 1-11. The reduction ranges from 15% to 50%.

# **II. SCHOLARSHIPS/DISCOUNTS**

# **III. PRESCHOOL PROGRAM**

Cedar Grove Christian Academy offers 3 program schedules for pre-kindergarten and kindergarten. (See Preschool Fees Schedule for pricing.)

Our morning program meets for 3 3/4 hours from 8:15 a.m. to 12:00 a.m.

Our <u>school day program</u> meets during the regularly scheduled school day from 8:15 a.m. to 3:00 p.m.

Our full day program has hours available from 7:00 a.m. to 6:00 p.m.

## **IV. BEFORE & AFTER SCHOOL PROGRAM**

Extended day services are available from 7:00 a.m. to 7:45 a.m. and/or from 3:00 p.m. to 6:00 p.m. daily for students in Grades 1-8. Flexible hours are billed at \$5.50 per hour. After 6:00 p.m. pickup is charged \$20 for each 15 minutes interval or part thereof!

## V. DISCOVERY PROGRAM

Discovery is a program that provides educational therapy for students with learning problems. It is for students with *average* to *above average* intelligence who have specific deficits in perception and/or cognition. Since this program involves individual therapy sessions taught by certified teachers, the fee for this service is <u>in addition</u> to the regular classroom tuition. See fee below.

# VI. FINANCIAL POLICY

Cedar Grove Christian Academy seeks to keep tuition as affordable as possible in order to maintain a quality Christian education.

<u>Plan A</u> is a monthly payment plan using F.A.C.T.S. Management Company to process automatic withdrawals.

<u>Plan B</u> is a single payment due August 1 having approximately a 5% discount.
